SOAR! Helps in an Emergency

October, St. Michael Villa, the retirement home for the Sisters of St. Joseph of Peace in Englewood Cliffs, New Jersey, was seriously damaged in a fire. All of the Sisters evacuated safely, but they needed help meeting their immediate needs.

Thanks to our donors, SOAR! quickly responded. Within 24 hours, SOAR! sent the Sisters a \$10,000 grant.

Almost every request we receive has a degree of urgency, but there are times when something has to happen right away – and there is nowhere else to turn. In the past 12 months, SOAR! has awarded a half a dozen emergency grants. Requests included:

- a new oil tank for a congregation whose 54-yearold oil tank gave up at the beginning of winter;
- a patient lift for an elderly Sister who would be

confined to her bed without it after she returned to the convent from the hospital; and

• a security system for Sisters, so that they could have peace of mind after a break in.

More and more, congregations are turning to us to help them not only with planned renovations, but in emergencies as well.

With limited resources, Catholic religious know how important it is to make careful plans for the future. But they also know how quickly an emergency can throw them off track. In times like these, SOAR! is there to support them.

You help us continue to be that reliable resource for aging Sisters, Brothers and Priests in their time of need.
