Our Policy

SOAR! respects the privacy of our online visitors. We do not require you to register or provide personal information to us in order to view our site. We gather personal data, such as names, addresses, zip/postal codes, email addresses, and phone numbers only when voluntarily and knowingly submitted by a visitor.

What we do with the information we collect? Do we share it with anyone else?

If you make a donation on line, we may occasionally send you postal mailings regarding our mission and programs. We will use your email address or phone number to contact you if we have a question regarding your donation.

From time to time SOAR! rents or exchanges its list of supporters with other trusted organizations to benefit our programs and activities. Only your name and postal address would be shared with other organizations. We are extremely selective in choosing the organizations we associate with in this manner. Email addresses

Email addresses are obtained from website visitors only by opt-in format. At no time do we ever share your email address with any other organizations, persons, or parties. We will use your email address to periodically send you updates, or to contact you about a specific request you have made. Individuals may opt-out at any time.

Your security online

SOAR! uses a third party to manage credit card and electronic fund processing. The company we use is not permitted to store, retain, or use the information provided except for the sole purpose of credit card processing. Our site uses Secure Socket Layer (SSL) technology to help protect against the loss, misuse, and alteration of the data under our control. SSL is a proven coding system that automatically encrypts, or scrambles, data before you send it to us.

Are my donations tax-deductible?

SOAR! is a 501(c) 3 non-profit organization which is qualified to receive tax-deductible donations. Your donation is tax-deductible to the full extent of the law. Although a contribution to a charitable organization is generally deductible by individuals who itemize their deductions, an individual's right to such deduction is subject to a variety of limitations, including the obligation to obtain an acknowledgment regarding contributions of \$250 or more from the charitable organization. SOAR! recommends that you consult with a tax professional regarding the tax deductibility of any contribution.

How do we use cookies?

"Cookies" are small files that allow us to understand how you clicked to our site and what pages you click on during your visit to our website.

The SOAR! website does not store long term cookies but does use a temporary cookie related to tracking (anonymously) visits to the website that are associated with Google Analytics. These cookies are used to record website visits and return visits and expire within 24 hours. These cookies do not track our visitors' usage of other websites.
